PROGRESS REPORTin the cases ofHUNTEMANN/GISKAS.15.6.45.F.A.K. 507 and Subsidiary Trupps

Information on F.A.K. 507 and its subsidiary Trupps has been given by GISKAS as follows:-

"In the winter of 1943/44, the situation from an Abwehr III point of view in France, Belgium, and to a certain extent in Holland, demanded an intensification of both offensive and defensive work of the German III.F. section. According to knowledge to hand it was clear that:-

- a) The organisation of Resistance and sabotage groups, armed and equipped by the enemy, was making rapid progress.
- b) A well functioning a/T agent net with extensive means of communication was continually being expanded.
- c) Enemy espionage activity in regard to aims and quality of results had turned out to be a military threat of the first order.

"The question was purely this: Could the German Oberkommando-sekt reckon on continually, if at all, being able to counter more effectively this menace, in view of:-

- a) Lack of means in regard to personnel and technical requirements.
- b) The readiness on the part of the civil population to make sacrifices which were bound to increase, whilst the difficulties of the Occupation authorities were augmented.
- c) Mistrust on the part of the R.S.H.A. towards everything that was not S.S. or Partei, which resulted in all units under command of the R.S.H.A. trying to encroach on Abwehr territory.

"In view of this situation it was necessary first of all to withdraw the III.F. service from the structure of Abwehrstellen and to form them into independent Trupps. The following military considerations led to the final order in this respect:-

- a) Putting the III.F. units on a mobile basis for the event of a possible war of movement in the west.
- b) Stricter control, more uniform principles, and more rapid appreciation and analysing of the results.
- c) The placing of F.A.K. commanders directly under the Ic of Army groups and the Stabscheffe of the military G-in-C, with a view to ensuring their continual and direct briefing and the immediate carrying through of orders regarding reconnaissance, or deception, of the enemy.

My former activity as an Abwehr officer, within the normal meaning of the word, came to an end with the order to form, equip, brief and command, both technically and from a regimental standpoint, PAK 307, with its subordinate PAKs 362, 363, 364 and 365. The area allotted to PAK 307 comprised the region from Baden to the south of the Saarre, I had to keep the Wehrmacht's C-in-C for Holland, as well as the military C-in-C for Belgium and Northern France, continually informed concerning the enemy espionage (Abwehr) situation. This had to be carried out by means of regular conferences. The actual IIIF work was carried out independently by the PAKs. (The case of LIEDEKIND, who was run by the Kdo. was an exception to this rule). Apart from a few basic orders, the Truppe commanders were given a free rein in their decisions. The completion of the formation of the PAK and PAKs were continually delayed owing to the lack of personnel and material and had still not been completed by June 1944, in spite of the order which was issued in January 1944."

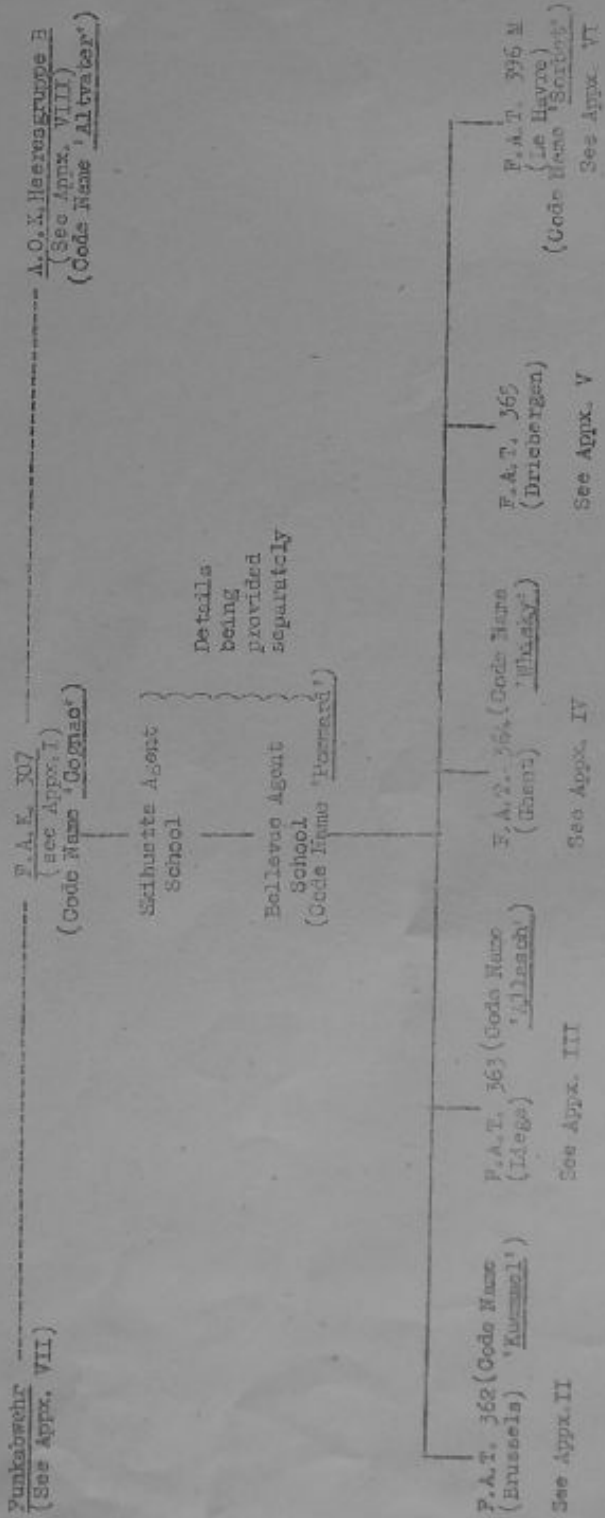
HUNTSMAN states that PAK 307 had been stationed at Brussels since March 1944. The main part left Brussels on 3rd September, 1944, the remainder having left two days earlier, and went to the Schloß Hillenrood bei Roermond in Holland. From there, in the middle of September, the newly formed Staffel II (all superfluous staff, under the command of Hauptmann WURR) was transferred to Kierspe-Bahnhof, where they remained until April 1945. These were people not suitable for the Abwehr and therefore redundant. The remainder of the Kommando went about the end of September to Bersdorf bei Bonn, and from there, a few days before the occupation of Bonn, to Hoenningen. In mid-March, 1945, as the front got nearer, the Kommando went to Hoesinghausen bei Plettenberg in Westphalia, where it finally broke up.

Attached is a table showing the set up of PAK 307 and its Truppe, together with descriptions of personnel, also diagram of #/T network.

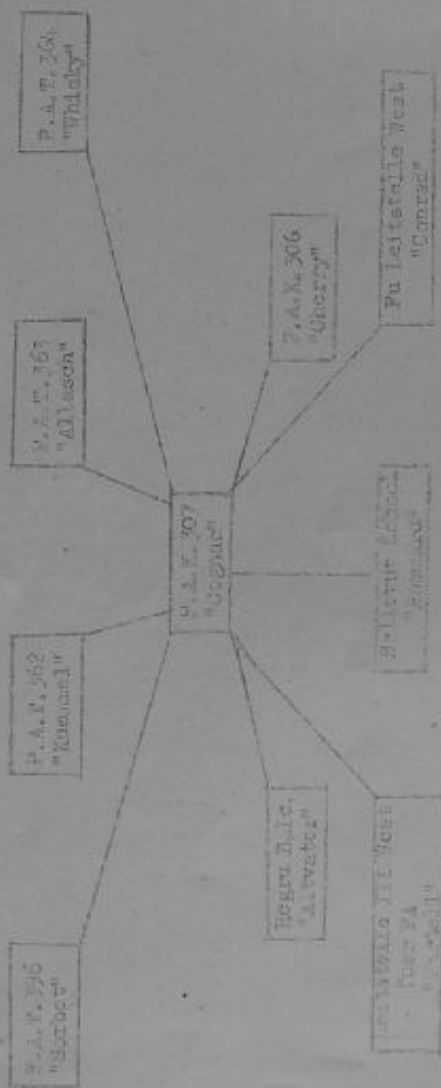

Came to FAK 307 in March 1944, from the German Embassy in Lisbon where he had been employed with A.O. Employed as analyst of information with FAK 307. Oct. 1944, ordered to PAT 364. Missing since about 8th April 1945 in Berleburg Sauerland area, probably killed. Civilian occupation: reception manager in hotel.

Description: German; aged about 35; plump build; height about 1.70m; light brown hair; blue-grey eyes; round face; cleanshaven; usually civilian clothes; speaks Spanish, English, French; address: Berlin.

Description: German; aged about 35; medium build; height 1.75m; brown hair; brown eyes; round face; healthy complexion; cleanshaven; appearance of a teacher; infantry uniform; speaks French.

11. Cofr. BOENDEL.

Came from 1st Paris to FAK 307 in March 1944, where employed in connection with analysing of information and reports. At his own wish was transferred to a PA III Troop in France, in June or July 1944, where he was set up as W/T operator. In peacetime was director of the INBERT GEMERATSKEN-PHARBEK in Paris, and is married to a Russian woman.

Description: German; aged about 35; powerful build; height about 1.78m; dark brown hair; clean-shaven; appearance of a boxer; civilian clothes; speaks French.

Description: German; aged about 35; firm build; height about 1.75m; weight 80 kg; brown hair; full face; healthy complexion; appearance of a business man; respectable clothes; speaks French.

Description: German; aged about 30; slim build; height 1.80m; (from GISKES) dark hair; dark eyes; narrow face; healthy complexion; cleanshaven; infantry uniform; speaks French and English ?.

- 15. Feldw. WALLENTAHN, 1942-43 employed in the registry of III C, Ast
Gerhard. Paris.
April 1944, employed with PAK 307 on personal records.
From Sept. 1944 Abwehrgehilfe and finally ordered to Trupp 363 or 364 in 1945.
Missing in Berlsburg area (Sauerland) since about 8th April 1945, probably killed.

Description: German; aged about 32; small build; height about (from HUNTEMANN) 1.68m; black hair; wears glasses; cleanshaven; scholarly appearance; speaks French. Address: Cologne.

Description: German; aged about 35; slender build; height (from GISKES) 1.75m; dark hair; dark eyes; wears glasses; narrow face; pale complexion; cleanshaven; schoolmaster type; infantry uniform.

- 16. Feldw. STEINBUCHHEL. 1944 (March) till March 1945 served as Hauptfeldw with PAK 307 - useless in Abwehr matters and not used. Missing since beginning of April 1945 in the Moehnetal pocket. Civilian occupation: Dealer in carpets and rugs.

Description: German; aged about 50; slim build; height about (from HUNTEMANN) 1.76m; grey hair; cleanshaven; wore uniform; whining voice; speaks German with Rhenish accent.

Description: German; aged over 50; medium build; height about (from GISKES) 1.75m; greying hair; dark (?) eyes; wrinkled face; appearance of a business man; artillery uniform.

17. Feldw. SCHWABNER.

Formerly in a Southern French Ast as Abwehrgesilfte. March 1944 till March 1945 employed with PAK 307 on matters dealing only with personnel and administration, on account of lack of qualifications. Seen by HUNTEMAN as a prisoner on 15.4.45. at the Flakkaserno in Luedenscheid.

Description: German; aged about 35; thickset; height about 1.72m; light brown hair, bald spot; grey eyes; originally cleanshaven, later small moustache; wore uniform; very loud and shrill voice; stubborn Prussian officer type; speaks French and German with Kuerttsenberg accent.

Description: German; aged about 40; solid, well-build; height 1.76m; thin, fair hair; blue eyes; narrow face; fresh complexion; cleanshaven; appearance of a clerk.

18. Feldw. SCHUEMANN.

1944-45 employed in PAK 307 on administration and welfare work only, ~~was~~ unsuitable for Abwehr work. Was with PAK 307 at the last H.Q. in the Seesen area in the Harz, at the beginning of April 1945, and missing since then.

Description: German; aged about 32; puny build; height about 1.70m; fair hair; blue-grey eyes; pale complexion; cleanshaven; wore uniform; hoarse voice; speaks German with Hamburg accent. Address: Hamburg.

Description: German; aged about 35; slim build; height about 1.70m; fair hair; blue (?) eyes; pale, narrow face; cleanshaven; appearance of a clerk; wore infantry uniform.

19. Offz. CHRISTMANN (II)

1944-45 employed as clerk in the Vorzimmer of the KSto. Fuehrer of PAK 307. Missing since 12.4.45. in Ruhr pocket.

Description: German; aged about 30; slim build; height about 1.76m; fair hair; blue eyes; cleanshaven; very youthful appearance; wore uniform; speaks German with South German accent.

Description: German; aged about 30; slim build; height 1.75m; fair hair; blue (?) eyes; narrow face; cleanshaven; infantry uniform.

20. Feldw. LANGINGER.

Prior to 1944 was administrative Feldwebel on an aeroplane in North France. 1944-45 clerk in the Vorzimmer of the KSto. Fuehrer of PAK 307. Missing since 12.4.45. in the Ruhr pocket.

Description: German; aged about 35; broad build; height about 1.75m; dark brown hair; cleanshaven; Luftwaffe uniform; speaks German with Bavarian accent.

Description: German; aged about 35; tall, slim build; height 1.75m; dark hair; dark eyes; cleanshaven; appearance of an office worker; wore Luftwaffe uniform.

21. UFFz. HAMM, Joseph 1940-44 driver with Ant-Niederlande, III F. 1944-1945 officer with FAK 307 in charge of administration of lorries, arms and equipment. Missing since 8.4.45. in Herleburg, Saucrland, probably killed.

Description: German; aged about 35; slim build; height (from HUNTEMANN) about 1.70m; light brown hair, very grey; grey eyes; cleanshaven; Luftwaffe uniform; always had his hair shaved very short to hide bald patches on the back of his head which only showed when his hair was long.

Description: German; aged about 40; slim build; height (from WICKES) 1.75m; greying hair; blue eyes; narrow face; healthy complexion; cleanshaven; appearance of a manual worker; Luftwaffe uniform.

22. UFFz. PEROLE Jan. 1944 came from Ant Dijon to FAK 307 as W/T operator for the signals section (not W/T agent), and remained there until April 1945.

Description: German; aged about 27; powerful build; height (from HUNTEMANN) about 1.70m; black hair; brown eyes; wears glasses; tanned complexion; cleanshaven; wore uniform; speaks German with Baden accent.

Description: German; aged about 25; slim build; height (from WICKES) above 1.80m; dark, curly hair; dark brown eyes; wears glasses; narrow, thin face; brownish complexion; cleanshaven; intelligent appearance, like a teacher; wore infantry uniform.

23. Frau STOLTEFOHN Details and description sent under Appx. IIIa (Ant Niederlande Personnel) to Progress Report dated 5.6.45.

24. Frl. JANSSEN Details and description sent under Appx. IIIa (Ant Niederlande Personnel) to Progress Report dated 5.6.45.

25. Frl. GRAU Oct. 1939 with ABF Berlin (as secretary).
3 ALEXANDRA Aug. 1940 - April 1944, with ABF Paris. June 1944 went to FAK 307 in Brussels, where she succeeded Frau STOLTEFOHN. End Aug. or Sept. 1944 went to military Dienststelle in Berlin (probably the department of Ant Berlin dealing with the winding up of camps and Abwehr matters.)

Description: German; aged about 24; average build; height (from HUNTEMANN) about 1.60m; dark brown hair; grey eyes; civilian clothes; speaks French, English.

Description: German; aged about 24; medium height, well-built; height 1.70m; brown hair; blue eyes; full face; healthy complexion; well kept hands; ladylike appearance; respectable clothes.

HUNTEMANN states that in addition to the above, there were about 25 soldiers acting as guards, drivers, assistant W/T personnel, etc.

P.A.T. 362 (Address: rue de la Loi, Brussels - Ast-Belgien building)
(Code Name 'Kuessel')
and
Aussenstelle Lille.

After the evacuation of Lille and Brussels, PAT 362 moved first to the neighbourhood of Solives Hillebrand bei Roermond. After PAK 307 left Hillebrand, Aussenstelle Lille moved in. The major portion of PAT 362 went to a small place near Hasselt. Its ultimate destination is unknown but, unlike the other units of PAK 307 which went to the Ruhr valley, it was forced away beyond Kassel. The Truppfuehrer, Major MOEHRING, was discharged for health reasons about October 1944 and replaced by Hptm. FISCHER.

a) Personnel.

1. Major MOEHRING.

1942-44 Referatsleiter III F, Ast Belgien, in Brussels.
March-about Sept. 1944 Truppfuehrer of PAT 362.
October 1944 discharged from PAT 362 for health reasons. Replaced by Hptm. FISCHER.
Civilian occupation: Amtsrichter in Bavaria.

Description: German; aged about 60; thick-set; height (from HUNTERMANN) about 1.70m; dark blond hair; wears horn-rimmed glasses; cleanshaven; civilian clothes; very loud and blustering voice; very nervous and irritable; speaks German with Bavarian accent.

Description: German; over 50; thickset, fat; height about (From GILBERTS) 1.70m; bald; brown (?) eyes; wears glasses; round fat face; healthy complexion; cleanshaven; academic appearance, heavy drinker; artillery uniform or plain civilian clothes.

2. Hptm. NEUBERS.

1945 with Ast Brussels, III F.
1944 in Brussels with PAT 362.
June or July 1944 shot in a town in the south of Belgium during an attack by Belgian Resistance men.
No description.

3. Hptm. WIESEMANN.
O. FELDMANN.

1945-44 Hilfsoffizier III F, Ast Brussels.
Since the formation of the FA Trupps, employed as Hilfsoffizier to PAT 362 and 364 alternately.
Oct. 1944 Truppfuehrer of PAT 362.
February 1945 Truppfuehrer of PAT 364 in succession to Hptm. MEER.

Description: German; aged about 50; medium build; height (from HUNTERMANN) about 1.70m; blond hair, slightly graying; blue eyes; wears glasses for reading; reddish complexion; large nose; cleanshaven; civilian clothes; loud voice; speaks French and German with Saxon accent. Lived before the war in Brussels.

Description: German; aged over 50; tall and fat; height over 1.80m; fair hair; blue eyes; long face; red complexion; long nose; cleanshaven; appearance of property owner; infantry uniform; speaks French.

Description: German; aged about 38; slim build; height about (from HUNTEMANN) 1.72m; blond hair; grey eyes; wears glasses; artificial teeth following a car accident; cleanshaven; scholarly appearance; civilian clothes; speaks English, French.
Address: Hamburg.

Description: German; aged about 40; medium build; height (from GISEKES) about 1.70m; fair hair; wears glasses; lean, wrinkled face; pale-brown complexion; cleanshaven; appearance of a teacher; speaks French.

- 5. Offz. NGRISE. Details and description sent in under Appx. IIIa (Ast-Niederlande Personnel) to Progress Report dated 5.6.45. (Hilfsoffizier with PAT 362.)

- 6. Offz. KOHL & RALPH. 1943-44 with III F, Ast Brussels. March 1944 to March 1945 with PAT 362. According to HUNTEMANN, lived in Brussels before the war, where he was employed with I.G. Farben Industrie.

Description: German; aged about 35; slim build; height about (from HUNTEMANN) 1.72m; blond hair; blue eyes; cleanshaven; civilian clothes; speaks English, French.

Description: German, aged about 30-40; medium build; height (from GISEKES) 1.75m; dark hair; dark (?) eyes; pale complexion; Latin appearance; elegant civilian clothes; speaks French.

- 7. Offz. or Oberoffz. COHRAD & QUILLARD. Previously with III F, Ast Belgien, and was sent to Brussels from March till August 1944 (with PAT 362). August 1944 was for a time in Mons at Ansecelle Mons of PAT 362. Oct. 1944 dismissed because of a motor accident, and was later said to have been transferred to Leitstelle I West.

Description: German; aged about 28; slim build; height about (from HUNTEMANN) 1.80m; black hair; brown eyes; cleanshaven; civilian clothes; speaks French.

Description: German; aged about 25; slim build, lanky; height about 1.80m; dark hair; dark eyes; narrow face; healthy complexion; cleanshaven; appearance of a student; speaks French.

- 8. Offz. or Oberoffz. ROHR. Previously with III F, Ast Belgien. March 1944 came to PAT 362 where he was employed in the analyzing of reports. Unsuitable for Abwehr work and, therefore, in October 1944 was trained as assistant W/T man for service traffic with PAT 307. Employed in this capacity until April 1945.

Description: German; aged about 28; slender build; height about 1.72m; dark brown hair; cleanshaven; civilian clothes; speaks German with Saxon accent.

HURTSMANN was responsible for the non-technical instruction of W/T operators. The instruction that he gave was based on the experience that he gained whilst operating the Nordpol affair. Each agent had about 10 hours' individual instruction from him, and he maintains that this was necessary in order that he should know intimately each operator as he states that this would assist in telling at a future date if the operator was acting under control. He thinks that during the Nordpol affair those handling S.O.E. agents in Holland lacked this intimate knowledge of their agents; if they had not, it would have been impossible for the Germans to have operated for such a long time.

R.D.F.

Normal procedure for R.D.F.ing was explained in some detail, i.e., static stations, mobile stations and portable sets. There seems to have been no very noticeable innovations in the German procedure.

Protective Measures against R.D.F.ing

Basic Rules

- a) Frequent change of headquarters.
- b) The operator to have as many W/T sets as possible in order to obviate transport of sets.
- c) Experience proved that in Holland R.D.F.ing was inaccurate in the neighbourhood of large stretches of water, therefore where possible transmit near water.
- d) During full moon R.D.F.ing is also inaccurate, therefore this is a good time for transmission.
- e) The importance of lock-outs.
- f) Previously reconnoitred escape routes.
- g) In the event of the doorbell ringing in a house where an operator is working, he must not cease work, as it is the practice to ring at all doors in the suspected neighbourhood and at the same time listen with a portable apparatus. If on a bell being rung, transmission ceases, the house is immediately pin-pointed.
- h) If a W/T set is to be transported it is advisable for one person to leave it in some such place as the cloakroom in a station, and for another person unknown to the first person to fetch it.

next symbol in the map reference should be D, but a word is used beginning with this letter. Thus the first part of the map reference would be 4 Dora. From the line D to the designated place, the number of millimetres is given, say, 54. Thus we have 4 Dora 54. Then the number marked on the righthand side of the map is taken, giving the numbering of the latitude, say, for example, 3. The reference now runs, 4 Dora 543.

Then the number of millimetres is taken from the designated place to the parallel line immediately below the place. This must always be a three-letter figure and if necessary a zero must be inserted in front of the number of millimetres - say, 72. The full map reference will read, 4 Dora 543072. To this six-figure number the agent adds his personal number, but with no carry forward, e.g., if the agent's number is 196835 the final figure will be

This number, of course, in the message would be enciphered.

Procedure if Arrested

If a W/T agent is captured and there is no possibility of his talking his way out, he should immediately hand over his code. Before setting off on a mission, the agent will have been supplied with two test questions. One of these test questions he will give away to the enemy, the other he will not. The test question he will give away will be the one which will immediately appear obviously to the enemy to be a test question, e.g., "When did your wife have her second child", the answer being "Uncle Theo was a heavy smoker". The answer to this question will of course entail reference by the enemy to the operator. The second test question which he will not disclose to the enemy is one which will contain a normal demand for information which the enemy can be expected to answer without reference to the operator, e.g., "Are the local trains in the neighbourhood of Brussels now running on schedule". To such a question the enemy, if controlling the operator, might be expected to answer without reference to him, whilst the real answer, agreed upon in advance, would be "Shall investigate and reply in next message".

The importance of indicating that he was being controlled was very much stressed.

Indicatives

To make it perfectly clear from whom a message comes, a suitable indicative is provided, namely, each agent in a group is allotted a letter, e.g., organiser A, W/T operator B. Locally recruited sub-agents will be numbered serially, thus, locally recruited W/T operator would be B.1.

Broadcasts

Crack messages for broadcasting to indicate infiltration or dropping operations etc. were taught, but the use of broadcast messages to inspire confidence in contacts was absolutely forbidden.

This instruction was based on HUNTEMANN's own ideas and as far as he knows was not used in other Abwehr Schools.

With reference to B.I.#'s (Mr. Wilson's) memo. of 8.6.45., HUNTEMANN and GISEKES were interrogated and the following information elicited:-

1. HUNTEMANN

a) TOUPAIN's Abwehr service

TOUPAIN told KUCHENBECKER and HUNTEMANN on the 25th November, 1944, that he had been working for the Gestapo in Munich, and further that he had worked for the Abwehr some time in 1941 for a certain Sonderführer, Freiherr von (name unknown).

According to himself he had been parachuted into North Africa in 1941 to spy on the French Post-Armistice Army. TOUPAIN, STEBIG and DAUERY all declared that they had been working for the Gestapo in Munich. TOUPAIN's story, however, of previous service in the Abwehr depends entirely upon his own statement which was not confirmed or checked by HUNTEMANN from other sources.

b) The NORA mission was initiated by TROOST of PAT. 363 and the only information that HUNTEMANN has about it is second-hand through a certain Serjeant SCHEISS, who was conducting N.C.O. for the group. Their primary task was to penetrate an alleged French Resistance group in Sappertal, composed of foreign workers in this region. HUNTEMANN thinks that possible instruction may have been given also to attempt to penetrate allied Intelligence Services by offering their services, as on the foundation of the school this was the primary role allotted to agents. He is quite certain that he has never heard of any long-term post-war roles having been allotted to any agent.

c) On arrival at the school each agent was given one or more contact addresses in Switzerland, which had been procured through Geffr. STAMLER of FAK. 507 in Bregenz. It is possible that the addresses given in Lichtenstein may have been procured through STAMLER. It is pointed out that the use of the contact addresses was for agents who received roles of penetration.

As regards the telephone no. Segur 09-81, it is thought by HUNTEMANN that this may have been given by KUCHENBECKER & KRAMER and be that of a certain Lydia BENCHOLE, the wife of a Jewish film director in Paris. KUCHENBECKER was known to Lydia BENCHOLE in the name of KRAMER and had been of assistance to her during the war. He apparently hoped for her help in reconstituting his career after the collapse of Germany.

JEAN JARIGE & JOSEPH: HUNTEMANN declares that as far as he can remember there was no connection between this man and the NORA mission, neither did he brief him for any mission. JOSEPH left for France via Switzerland some time about the beginning of March 1945, with the intention of returning to France via Switzerland. The various FAPs submitted proposals to GISKES for his approval. The briefing was done by the FAPs.

From the field report on TOUTAIN it is not clear who in fact briefed this man, but GISKES is quite certain that he did not brief him and that the brief was the same as that mentioned by HUNTEMANN. He maintains that no agent of his was ever given a long-term post-war mission by him.

c) The contact addresses mentioned were those procured by STADLER and given to each agent under instruction at the school.

GISKES' explanation of the telephone no. is the same as that given by HUNTEMANN.

HUNTEMANN/GISEES

Many thanks for the Progress Report of 5.6.45. This fully confirms my previous impression that these two are co-operating to the best of their ability.

The further steps to be taken on the S.O.E. angle were fully discussed at yesterday's meeting with S.O.E. and there is no need for me to comment further.

The preliminary statements made by these two about LINDEMANN are interesting and interrogation on this point in the light of LINDEMANN's own story should produce good results.

Stang, who handled the LINDEMANN case, has made the following comment: -

"Some of the information given regarding LINDEMANN is new to us. There had hitherto been no evidence that LINDEMANN gave away or could have given away any Allied military plan. The theory that he had been responsible for passing information regarding the abort operation was based on misleading information from most secret sources. Nor were we previously aware of the fact that LINDEMANN had been put in touch with agents who were parachuted into the northern Dutch province. The incident to which GISEES refers may well relate to the penetration of the organisation which S.O.E. attempted to set up in the spring of 1944, when the organisation which had hitherto succeeded was proved to be utterly penetrated. I am, however, somewhat surprised by GISEES' statement that the attempt to play back S.O.E. agents was immediately spotted in England.

An attempt was made after the arrest of LINDEMANN to warn the S.O.E. organisation in Holland of the fact

fact that his brother might be working for the Germans. I am not quite sure what signal was sent but so far as I can recollect it was not in the form described by GIBKES. On the other hand, the guess that he was given away by another agent (no doubt VERLOOP) is of course correct. "

I realise that it will take a lot of time to complete these cases. I should, however, be grateful if progress reports could be issued from time to time dealing with general III. matters, e.g. activities of Ant. VI 2, and the old Abw. III D, Leitstelle West, relations of III with R.S.H.A., long term plans if any, general instructions on penetration matters, machinery for deception through controlled agents, particulars of deception plans and cases. Such progress reports on the more central III organisation, as distinct from the local activities in Holland and of the RUK's and FRI's will be most useful in interrogating Oberst. KEELS who has just arrived at C.S.D.I.C. (U.K.).

GIERKE and HUSTENHAGEN

Mention has already been made of agents from the school at Wuhl called Christian Henri TOURNAIN & CLAUDE and two other men who were to undertake mission HORA. TOURNAIN and one of the others has been arrested and I enclose a copy of the preliminary field reports. The mission was given early in April. Contact was to be made between the end of May and 15th June. According to TOURNAIN he was told, when given his instructions in April, that the war was lost but the service would continue. This suggests that the mission was a post collapse mission and it is stated in a cable that the nature of the instructions indicate a long range programme. We have not yet received details of this programme - apparently precise mission and questionnaire only to be given after contact had been established either by W/T or through the Paris telephone number or through the letter boxes in Liechtenstein.

Another point is that in the field report HUSTENHAGEN states that TOURNAIN had been parachuted by the G.I.S. into North Africa in 1941 and has worked for the Abwehr ever since. This is, of course, in direct contradiction with TOURNAIN's preliminary interrogation and the field have therefore asked urgently regarding TOURNAIN's Abwehr service to assist them in interrogation of TOURNAIN which is now proceeding.

I should be grateful, therefore, if you could let us know as quickly as possible, in the first instance by telephone, the answers to the following points:-

- (a) Details of TOURNAIN's Abwehr service.
- (b) Comments on the mission likely to have been transmitted to these agents in June.
- (c) Any explanation of the suggested contacts in Paris or Liechtenstein.
