Dear John,

Would you be good enough to refer to your letter of 27.12.44 relating to De GRAAF. LINDEMANS was questioned regarding the message to which you refer. He states that Kaas BEVERDINK is in fact Kaas von BEVERDINK who is identical with De GRAAF. LINDEMANS himself composed the message. He knew from Dr. German that all the dropping grounds in Holland were known to the Germans and the W/T operators in Holland had been blown and were working under German control. Questioned about the message LINDEMANS was certain that REINIERS had transmitted it. He states that REINIERS promised to do so and later told LINDEMANS that he had sent it.

Mr. Pinto told me that the woman of whom he had no particulars whatsoever was a German agent. The photograph was shown to LINDEMANS who identified it immediately as that of the woman ^{SECRET} referred to in this report. Would you be good enough to file the photograph in LINDEMANS' file, and card JOHNNY on this note which should be filed accordingly.

Miss Chenhall has a recollection of a woman called JOHNNY who appeared in another case from the Field fairly recently. I do not know whether she could be readily identified. If so I would be grateful if you could let me know.

With reference to S.I.B. (Mr. Starn's) memorandum of 4.12.44, enclosing letter from Major DeLafosse of 2.12.44 (JD/KV/2259), LINDSIANS has been interrogated on the points raised with the following results:-

1. Mess BEVANDER should read Hans von WERDINGS, who is identical with LE GRAP.
2. LINDSIANS composed the message himself. As he was working for the Germans as well as the Resistance movement, he knew from Dr. GERMAN that all the dropping grounds in Holland were known to the Germans and the W/T operators (also in Holland) had been blown and were working under German control.
3. When questioned about this message, LINDSIANS was quite certain that REINIERS had transmitted it, stating that the latter had promised to do so and told LINDSIANS later that he had sent it.

One of our people in the field has informed me that he was talking recently to HENIERS the head of the A.S. at Antwerp about KING KONG, and he had mentioned that KING KONG had approached him at the beginning of May '44 with a request to send to London for the "Dutch Service" a message for Kaas BEVERDINK beginning with the code phrase, (Flemish or Dutch): "Chat dans la cuisine".

This message which was not sent said that all dropping grounds and W/T Operators were blown, and no more receptions could be arranged.

The above is not very clear, but I should be glad if you could clear up the following points by enquiring from KING KONG :-

- (1) Who was Kaas BEVERDINK. Did this refer to DE GRAAF as his first name is also Kaas?
- (2) Where did KING KONG get this message from?
- (3) Did KING KONG get the message through by any other means?

LEWISONS

With reference to R.I.O. (Mr. Stamp's) memorandum of 29th November, ref: P.F. 600,513, the following is information now given by LEWISONS on some of the persons mentioned, in addition to that already given in the interim reports:-

BOB:

Has dark brown hair, brushed back without parting.

BOULDER:

Broad-shouldered. Pallid complexion with pimples on forehead. Talks slowly, often with hands behind back; absent-minded air. Usually wears black suit, black tie and black felt hat, with white shirt.

WIM:

Brown hair, brushed back without parting, thinning over temples. Wears glasses with thick lenses (very short sighted). Hollow-cheeked. Front teeth large and prominent, and stained yellow through smoking. Fingers unusually long for a man, and very stained with nicotine. Loud voice. Heavy cigarette-smoker.

PROGENSEL:

One wooden arm and hand (probably the right).

SCHWABER & JANAK:

Age: about 33. Height: 1.65 m. Hair: brown or dark blond, brushed back with parting. Eyes: blue. Face: hollow-chin'd cheeks. Teeth: bad, some missing. Hands: normally wears several rings set with brilliants. Clothes: good. Voice: speaks in nervous jerks. Peculiarities: wears a gold wrist-watch and several rings. Does not smoke.

JAN:

Age: about 34. Build: broad-shouldered. Height: 1.65 m. Hair: dark brown or black. Eyes: brown. Complexion: brown. Teeth: good, very white. Dark moustache. Voice: quiet. Peculiarities: walks quickly.

Lieutenant PAUL:

Following the receipt of the yellow peril of 23.11.44. suggesting that Victor LIVANE was identical with Victor SWANE described by LINDEMANS, I rang up Camp 020 and spoke to Captain Bagge. I asked him whether LIVANE, as written in DEBRAY's note-book, could be SWANE, at the same time pointing out to Captain Bagge that I understood DEBRAY's handwriting was very bad and that there were a number of bad mis-spellings or mis-readings of names which we had received from Camp 020. Captain Bagge was insistent that the man that DEBRAY knew was known to him as LIVANE and he was reluctant to look at the note-book again. I asked him whether the notes were typed or written and he said he was not sure. I did prevail upon him to look at the note-book and he rang me back this morning and told me that the name as written certainly could be, and he thought it was, SWANE.

With reference to B.I.E (Mr. Stamp's) memorandum FP. 600,513/SBS of 29.11.44, a photograph of the S.O.E. agent LEMTUCE forwarded therewith was shown to LINDEMANS, who stated that it was most certainly not that of the ROMLOE known to him, who was at least ten years younger than the subject of this photograph.

Shown a photograph of AGAZARIAN @ GLAZIER @ MARCEL, LINDEMANS failed to identify it, though he said he thought he had seen the man somewhere. MARCEL, whose surname is CARLWY, was quite a different type, with many gold teeth and a flattish, African nose.

The negative result of the showing of these photographs to LINDEMANS was telephoned to Mr. Stamp this morning.
